



Complainant through brother alongwith counsel present.</p> <p>The accused/petitioners namely Abdul Waqib son of Gulistan, resident of Qom Mishti, village Sarla, District Orakzai has applied for his post arrest bail in connection with case FIR No. 44, dated: 324/353 Pakistan Panel Code, 1860, 11(1) CNSA & 15 Khyber Pakhtunkhwa Arms Act, 2013, registered in police station Mishti Mela District L/Orakzai.</p> <p>Arguments of the counsel for accused/petitioner heard.</p> <p>Perusal of record reveals that accused/petitioner is directly and by name charged in a promptly lodged FIR. The offence with which accused/petitioner is charged falls within the ambit of prohibitory clause of Section 497 Cr.P.C. Crime of empties also recovered from the place of accused/petitioner. Furthermore, ice also recovered from the direct possession of accused/petitioner. Moreover, site plan reveals that the present accused/petitioner is shown at point no. 01, which shows their presence on the spot. As per decisions of the Apex Superior Courts, deeper appreciation of evidence is not permissible at bail stage and only tentative assessment thereof is to be made just to find out connection of accused/petitioner with the commission of the offence. Sufficient material is available on file connecting the accused/petitioner with the commission of the offence. In the given circumstances the accused/petitioner is not entitled to the concession of bail. Consequently, the application is turned down. Copy of this</p>
