SUMMARY JUDGEMENT 16.07.2025

Plaintiff absent. Representative defendants of Authority letter and written statement submitted.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per Birth Registration Certificate, true and correct date of birth of plaintiff is 01.07.2004 which is also entered in his Birth Registration Certificate, however, defendants have incorrectly entered the same as 11.04.2009 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.
