

Petitioners/plaintiffs further stated that there existed a house in the suit property, which was constructed by their father before 40/50 years ago, so as to look after the suit property. They further stated that a deed dated 18.02.2016 was scribed between the parties regarding the joint ownerships and parties to the suit signed the same. On the other hand, respondents/defendants alleged that petitioners/plaintiffs were illegally and unlawfully dispossessed the defendants from the suit property. They also stated that the petitioners/plaintiffs are usurper and have their share of property as well.
