Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, her true and correct date of birth of plaintiff is **01.01.1975**, however, defendants have incorrectly entered the same as **01.01.1985** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, there is unnatural age of about 12 years between plaintiff and her son namely Reqad Ali whose date of birth is **01.01.1997**. That defendants were asked time

and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least

16/17 years' age difference between mother and her son. Per record,
