
SUMMARY JUDGEMENT-

07.08.2025


Plaintiffs absent. Representative of defendants present.

Authority letter & written statement submitted. Representative of
defendants stated that there is unnatural age gap of 02 years, 01 year
and 11 years between plaintiff No.1 with their children while there
is unnatural age gap of 01 year, 02 years and 12 years between
plaintiff NO.02 with their children. Arguments heard and record
gone through.

Brief facts in the backdrop are that plaintiff has filed the
instant suit for declaration cum-permanent injunction to the effect
that correct date of birth of plaintiff No.1 is **01.01.1954** and correct
date of birth of plaintiff No.2 is **01.01.1955**, however, defendants

have incorrectly entered the date of birth of plaintiff No.1 as 01.01.1974 and plaintiff No.2 as 01.01.1973 which are wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, the plaintiff No.1 is 02 years younger than his daughter namely Noor Zainab, plaintiff No.1 is 01 year elder than his daughter namely Bibi Um Salma and plaintiff No.1 is 11 year elder than his son namely Syed Muhammad Afif Hussain, similarly, plaintiff No.2 is 01 younger than her daughter namely Noor Zainab, Plaintiff No.2 is 02 year elder than her daughter namely Bibi Um Salma and plaintiff No.2 is 12 year elder than her son namely Syed Muhammad Afif Hussain. That defendants were asked time and again to rectify date of birth of plaintiffs but in vain hence, the present suit.



Representative of defendants stated that there shall be at least 16/17 years' age difference between daughter and her mother/father. Per record, date of birth of plaintiffs are recorded as 01.01.1974 & 01.01.1973. Date of birth of plaintiff's are recorded as 01.01.1974 & 01.01.1973, resulting that the plaintiff No.1 is 02 years younger than his daughter namely Noor Zainab, plaintiff No.1 is 01 year elder than his daughter namely Bibi Um Salma and plaintiff No.1 is 11 year elder than his son namely Syed Muhammad Afif Hussain, similarly, plaintiff No.2 is 01 younger than her daughter namely Noor Zainab, Plaintiff No.2 is 02 year elder than her daughter namely Bibi Um Salma and plaintiff No.2 is 12 year elder than her son namely Syed Muhammad Afif Hussain, how it possible. Plaintiffs are not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as

per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No.1 as **01.01.194** & **01.01.1955**. Suit of plaintiffs are decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
