



Order No.04		<p>After hearing both the parties and perusal of the record, it was found that the motorcycle in question was found in possession of the accused Aurangzeb at the time of registration of case. He was acquitted vide judgment dated 12.12.2024 by the court of Additional Sessions Judge-I, Orakzai and the motorcycle in question was directed to be kept intact till the expiry of period of appeal/revision. After the expiry of said period, the petitioner submitted the instant application for superdari of the motorcycle No. CHK 1223. He has annexed a Sale deed dated 05.06.2021 executed in respect of the motorcycle in question in his favour. However, the stamp paper used for scribing the sale deed in question was issued on 11.05.2024. When the learned counsel for the petitioner was confronted with the said fact, he could not reply satisfactorily.
