

Order No.05	02.09.2025	<p>Accused/petitioner, Stori Khel on ad-interim pre-arrest bail with his counsel present. Sr. PP, Abul Qasim for the State present. Complainant present in person. Complete record received.</p> <p>The accused/petitioner seeks pre-arrest bail in case FIR No. 72, Dated 05.08.2024, u/s 324/337-F(i) PPC of Police Station Kalaya. As per contents of FIR, the complainant, vide his application u/s 22-A of the Criminal Procedure Code, 1898 for registration of FIR against the accused reported that he is residing in Hangu Road Nawey Kaley, Kohat and his first wife has died from whom he has 04 children and he has married the daughter of accused and have a child from her too. He further reported that he was travelling on Bezot road on 23.06.2024 when his brother-in-law, Mohsin Ullah signaled him to stop for taking him to his house on the call of his sister (wife of complainant) and when they reached to the house of accused/petitioner who present at the main gate and a squabble started between them and the petitioner made firing upon the complainant with his pistol; as a result, he sustained injury on his thigh.</p> <p>After hearing both the parties and perusal of the record, it was found that the instant FIR has been registered against the accused/petitioner on the basis of</p>

		<p>application u/s 22-A of the Criminal Procedure Code, 1898 by the Order Dated 23.07.2024 of this Court. Medico legal report supports the case of prosecution. The accused/petitioner has remained fugitive from law for a period of about 01 year and he failed to point out any malafide or ulterior motive on behalf of complainant for falsely implicating him in the instant case.</p> <p>Hence, the accused/petitioner is not entitled to concession of pre-arrest bail at this stage. Therefore, ad-interim bail earlier granted to the above-named accused/petitioner is hereby recalled and the BBA in hand resultantly stands dismissed.</p> <p>File of this Court be consigned to record room after its necessary completion and compilation.
