

Plaintiff through counsel present. Representative of defendants

present. Written statement submitted. Representative of defendants

stated that per record, there is unnatural age gap of 13 and 15 years


between plaintiffs with their daughter, therefore, if suit of plaintiffs

are disposed of through summary judgement, he has got no objection.

Arguments on behalf of representative of defendants heard and record

gone through.

Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction to the effect that, true and correct date of birth of plaintiff No.1 and Plaintiff No.2 are 01.01.1957 respectively, however, defendants have incorrectly entered the same as 01.01.1960 and 01.01.1962 which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That due to this wrong entry, there is unnatural age of about 13 and 15 years between plaintiffs with their daughter namely Mahbooba Mawiz whose dates of birth is 01.01.1975. That defendants were asked time and again to rectify date of birth of plaintiffs but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

Representative of defendants stated that according to NADRA SOPs there shall be at least 16/17 years' age difference between parents with their daughter. Per record, date of birth of plaintiff No.1 is 01.01.1960 and plaintiff No.2 is 01.01.1962 while date of birth of plaintiff's daughter namely Mahbooba Mawiz recorded as 01.01.1975 resulting into unnatural age gap of about 13 and 15 years. Plaintiffs


are not a government servant. The modification sought by plaintiffs will not affect rights of others. Representative of defendants stated that date of birth of plaintiffs may be modified as per NADRA SOPs.

There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No.1 & plaintiff No.2 are 01.01.1957 respectively. Suit of plaintiffs are decreed as prayed for.

No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
