
SUIT FOR DECLARATION & PERMANENT INJUNCTION.

SUMMARY JUDGEMENT

06.08.2025

Plaintiff through counsel present. Representative of defendants present. Written statement submitted. Representative of defendants stated that there is unnatural age gap of 11 years between plaintiff and his mother namely Muhmanda Bibi. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, his true and correct date of birth of plaintiff is **16.09.2002**, however, defendants have incorrectly entered the same as **16.09.1996** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, there is unnatural age of about 11 years between plaintiff and his mother namely Muhmanda Bibi whose date of birth is **01.01.1985**. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between son and his mother. Per record, date of birth of plaintiff is recorded as 16.09.1996. Date of birth of plaintiff's mother namely Muhmanda Bibi is recorded as 01.01.1985 resulting into unnatural age gap of about 11 years. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **16.09.2002**. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
