Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per DMC and Birth Registration Certificate, true and correct date of birth of plaintiff is 03.03.2009 which is also entered in his DMC and Birth Registration Certificate, however, defendants have incorrectly entered the same as 09.08.2002 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement filed.

Plaintiff has placed reliance on DMC and Birth Registration Certificate. Per DMC and Birth Registration Certificate, date of birth of plaintiff is recorded as 03.03.2009. Representative of defendants stated that date of birth of plaintiff may be modified as per DMC and Birth Registration Certificate per NADRA SOPs. Copy of DMC and Birth Registration Certificate of plaintiff is placed on file.
