
Shabbir Khan present and his statement recorded as PW-07. Accused is absconding.

Perusal of record shows that accused namely Din Ullah S/O Awal Meen Shah resident of Qoum Othman Khel, Tappa Branka Khel, Kado Khel District Lower Orakzai is charged in the above cited case for the commission of the offence in case FIR No. 02, dated 10.01.2023, U/S 11-A CNSA registered at PS Kalaya.
