SUMMARY JUDGEMENT 06.10.2025

Plaintiff present. Representative of defendants present AWRITED JUNAID ALAN CIVIL STREET AND JUNAID ALAN CIVIL STREET AND ALAN Orakzai at Kalaya orakzai at Kalaya statement submitted.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per Birth Registration Certificate, true and correct date of birth of plaintiff is **01.10.2003** which is also entered in his Birth Registration Certificate, however, defendants have incorrectly entered the same as **22.03.2010** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement filed.

Plaintiff has placed reliance on Birth Registration Certificate. Per Birth Registration Certificate, date of birth of plaintiff is recorded as 01.10.2003. Representative of defendants stated that date of birth of plaintiff may be modified as per Birth Registration Certificate per NADRA SOPs. Copy Birth Registration Certificate of plaintiff is placed on file. Plaintiff shall produce Birth Registration Certificate to the office of defendants for the modification in date of birth as 01.10.2003. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.10.2003** accordingly. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
