

Post-Script	11.09.2025	<p>None present for the State. Later on, accused Mustafa stated at the bar that he wants to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file.</p> <p>Brief facts of the case are that as per version of the complainant in the FIR, on 13.05.2025 at about 16:00 hrs complainant SHO was on routine patrolling. During patrolling the accused Mustafa in suspicious condition was stopped for the purpose of checking. Upon his body search the local police recovered and took into possession 50-grams ice from the left side pocket. Accused was arrested and issued his card of arrest.</p> <p>Complete challan against the accused was put in court and after 241-A Cr.P.C proceedings, the accused facing trail was formally charge sheeted. Accused Mustafa pleaded his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.</p>

<i>Post-Script</i>	11.09.2025	<p>It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused was previously involved in such like cases. There is also no criminal history of the accused available on the file.</p> <p>Keeping in mind the wholehearted confession of guilt by the accused facing trial and being a first offender, a lenient view is taken and accused is convicted and sentenced for offence under section 11-A CNSA with simple imprisonment of 04 months with fine of Rs. 20,000/-. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of one month. Benefit of 382-B Cr.P.C. is extended to the accused. Case property be dealt in accordance with law.
