

Complainant in person alongwith counsel present.</p> <p>Vide this order this Court intends to dispose of the instant case under section 249-A Cr.PC.</p> <p>Brief facts of the case folded in FIR, that complainant Khawaja Muhammad son of Aqiq Rehman, resident of Qom Sultanzai, District Orakzai, came to the police station and reported to the local police, that on the day of occurrence, he was busy in cultivation in his property through tractor. At about 15:00 hours, the accused Ashna Deen, Nandar Khel, Asghar, Nusrat, Sher Wali, Barkat Ullah, Rehman Gul, Polad came to the spot and told us to stop cultivation. Complainant stated that the property is his ancestral since the time of his fore-fathers. Upon the same the accused mentioned above angers and used abusive language. Accused mentioned also aiming pistol for criminal intimidation and they also forcibly evicted from his property. The motive behind the offence was dispute over the landed property, hence, Naqal Mad no. 06 dated 05.05.2024 was lodged against the accused facing trial.</p>




Contd. Order 11	09.09.2025	<p>Accused were arrested and later on, released on bail. Complete challan was put in court against the accused. Accused were summoned. They appeared before the court. Provisions of Section 241-A Cr. PC were complied with. Formal charge was framed. Accused pleaded not guilty and claimed trial. Prosecution was allowed to produce evidence against accused facing trial. Prosecution produced one witness. i.e. PW-01 Muqadar Khan in the instant case. His only examination in chief recorded.</p> <p>Perusal of the record would transpire that complainant charged the accused facing trial to criminally intimidate him, however, not a single empty has been recovered from the spot or places of accused. It is also worth mentioning here that the instant case was registered against the accused facing trial on 01.10.2024 and since then, the prosecution only produces a single witness before the court, which shows their lack of interest in prosecution of the case. It is also worth mentioning here that prosecution submitted abatement challan against the accused Nandar Khan on 07.06.2024, which perused that the accused has been died on 04/07.2020, prior to the occurrence taken place, which makes the prosecution story doubtful.
