Accused were arrested and later on, released on bail. Complete challan was put in court against the accused. Accused were summoned. They appeared before the court. Provisions of Section 241-A Cr. PC were complied with. Formal charge was framed. Accused pleaded not guilty and claimed trial. Prosecution was allowed to produce evidence against accused facing trial. Prosecution produced one witness. i.e. PW-01 Muqadar Khan in the instant case. His only examination in chief recorded.

Perusal of the record would transpire that complainant charged the accused facing trial to criminally intimidate him, however, not a single empty has been recovered from the spot or places of accused. It is also worth mentioning here that the instant case was registered against the accused facing trial on 01.10.2024 and since then, the prosecution only produces a single witness before the court, which shows their lack of interest in prosecution of the case. It is also worth mentioning here that prosecution submitted abatement challan against the accused Nandar Khan on 07.06.2024, which perused that the accused has been died on 04/07.2020, prior to the occurrence taken place, which makes the prosecution story doubtful. Accused facing trial are facing agony of trial since 2024. Even otherwise, there
