

In such like cases grant of bail is a rule and refusal an exception. No extra ordinary circumstances exist to justify departure from the said rule. Nothing incriminating has been recovered from possession of the accused/petitioners.</p> <p>Accused/petitioners were not arrested on the spot. Medico legal report does not support the version of prosecution</p> <p>Investigation has already been completed and accused/petitioners are no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioners behind the bar.</p>
