

Record received.</p> <p>Accused/petitioner namely Adam Khel son of Gul Muhammad, resident of Qom Mishti, Shalzara, District Orakzai has applied for his post arrest bail in connection with case FIR No. 70, dated: 14.08.2025 under sections 382/506/504/341/109/148/149 Pakistan Panel Code, 1860 registered in police station Mishti Mela, District Orakzai.</p> <p>Perusal of record would reveal that the alleged occurrence took place on 14.08.2025 at about 17:00 hours and it was reported on 22.05.2024 at about 17:50 hours and FIR was lodged on 17.08.2025. Although the offence for which the accused/petitioner was charged fall within the ambit of prohibitory clause of Section 497 Cr.PC, however, record show that accused/petitioner along with co-accused are nominated in the FIR by complainant without disclosing any source of information regarding involvement of the co-accused in the commission of the offence. No recovery has been effected from the direct possession of the present accused/petitioner or on his pointation. There is no independent eye witness in the inquiry. No statement of the</p>

	<p>accused party has been recorded. Accused have not confessed their guilt before the court. Moreover, co-accused in the instant case released on bail, hence, rule of consistency is extended to the present accused/petitioner. There is no criminal history of accused/petitioner which could show his involvement in such like cases. Record further transpire that the section of law for which the accused are charged are not attracted to the occurrence. Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar. Consequently, the case of further inquiry, therefore, bail petition in hand is hereby allowed. Accused/petitioner be released on bail subject to furnishing of bail bonds to the tune of Rs: 100,000/- (one lac) with two local and reliable sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police record as well as judicial record. Record be sent back forthwith to the concern police station.
