



Record received.</p> <p>Accused/petitioner namely Sultan Gul son of Hazrat Noor, resident of Qom Shiekhan, Tapa Umerzai, village Kachmela, District Orakzai, seeks his post arrest bail in case FIR No. 75, dated: 02.09.2025 under sections 406/34 Pakistan Panel Code, 1806 registered at Police Station Mishti Mela, District Orakzai.</p> <p>Arguments of learned counsel for accused/petitioner heard and record perused.</p> <p>Perusal of the record would reveal that complainant lodged instant FIR against the present accused/petitioner alongwith co-accused for breach of criminal trust. Record further transpires that the alleged occurrence took place on 14.04.2014, it was reported on 23.06.2025 and F.I.R was registered against accused/petitioner on 02.09.2025. Furthermore, the offence for which accused/petitioner is charged does not fall within the ambit of prohibitory clause of Section 497 Cr. P.C. In such like cases grant of bail is a rule and refusal an exception. No extra ordinary circumstances are available on record for refusing bail of accused/petitioner.
