SUMMARY JUDGEMENT
14.10.2025

Plaintiff through counsel present. Representative of
defendants present. Representative of defendants submitted written
and stated that there is unnatural age gap of 15 and 11 years between
plaintiff with her parents namely Muhammad Ikram Khan and Mst:
Umar Khela. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the
instant suit for declaration cum-permanent injunction to the effect that
her true and correct date of birth is **01.03.1991**, however, defendants
have incorrectly entered the same as **1985** which is wrong, illegal and
ineffective upon the rights of plaintiff and liable to be rectified. That



due to this wrong entry, there is unnatural age difference of about 15 and 11 years between plaintiff with her parent. Date of birth of parent of plaintiff are 01.01.1972 and 17.01.1974. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between daughter with her parent. Per record, date of birth of plaintiff is recorded as 1985. Date of birth of plaintiff's parents namely Muhammad Ikram Khan and Mst: Umar Khela are recorded as 01.01.1972 and 17.01.1974, resulting into unnatural age difference of about 15 and 11 years. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.03.1991**. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
