

Record received.</p> <p>The accused/petitioner namely Nadir son of Nangeen Ali, resident of Qom Mani Khel, Zaridar, District Orakzai is seeking his post arrest bail in Case FIR No.57 dated: 27.05.2025 under sections 324/34 Pakistan Panel Code, 1860, Police Station Kalaya, District Orakzai.</p> <p>Arguments of learned counsel for accused/petitioner and counsel^{for} complainant heard.</p> <p>Although, accused/petitioner is directly and by name charged in the FIR by the complainant and the punishment for the offence under section 324 Pakistan Panel Code, 1860 falls within the ambit of prohibitory clause of Section 497 Cr. PC, however, no crime empties were recovered from the spot. Accused has not been arrested at the spot. Furthermore, no independent eyewitness of the occurrence. Moreover, medico legal report does not support the version of prosecution. Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind</p>
