



cases grant of bail is a rule and refusal an exception. No extra ordinary circumstances are available on record for refusing bail of accused/petitioner. There is no criminal history of present accused/petitioner as per available record. Accused/petitioner has not confessed his guilt before the court. Investigation has already been completed and accused/petitioner is no more required to the local police for investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar.

In light of above discussion, instant bail petition is hereby **accepted**. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 50,000/- (Fifty thousand) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. The requisitioned record be sent back to the quarter concerned forthwith, while file of this court be consigned to record room after necessary completion and compilation.
