Record already received.</p> <p>The accused/petitioner namely Stori Khel son of Akbar Shah, resident of Qom Bezot, District, Orakzai has applied for his post arrest bail in connection with case FIR No. 72, dated: 05.08.2024 under sections 324/337-F(i) Pakistan Panel Code 1860, registered in police station Kalaya, District Orakzai.</p> <p>Counsel for accused/petitioner has submitted written arguments in the instant bail petition.</p> <p>Perusal of record and written arguments of the counsel for accused/petitioner would reveals that accused/petitioner is charged directly for effective role. One of the offence under section 324 PPC falls within the ambit of prohibitory clause of Section 497 Cr. PC. It is a day light occurrence. It is also pertinent to mention here that present accused/petitioner <u>was absconding for a long time.</u> As per judgments of the Apex Superior Courts, deeper appreciation of evidence is not permissible at bail stage and only tentative assessment thereof, is to be made just to find out connection of accused/petitioner with the commission of the offence.</p>
