Moreover, site plan would reveal that the present accused/petitioners, duly armed with sticks and stone and assaulted on complainant, is shown at point no. 01, which shows their presence on the spot. As per decisions of the Apex Superior Courts, deeper appreciation of evidence is not permissible at bail stage and only tentative assessment thereof is to be made just to find out connection of accused/petitioners with the commission of the offence.


Consequently, application in hand is turned down. Copy of this order be placed on police as well as judicial record.
