
Relative of petitioner along with counsel present. He filed special power of attorney on behalf of petitioner. Inquiry report received, which is placed on file. Publication received but no one appeared on behalf of public at large hence, placed and proceeded ex-parte. Ex-parte arguments heard and record perused.

Petitioner namely Mst: Noor Khela Jan widow Sher Baz Ali, R/O Qaum Bar Muhammad Khel, Tappa Khwaidad Khel, Trangi Tehsil Lower, District Orakzai has filed the instant petition for grant of Guardianship Certificate regarding her minor children namely Kasrat Begum, Eshan Haider and Roma Batool. It has been alleged that petitioner is the widow of deceased Sher Baz Ali who died on 19.03.2015. It is further alleged that petitioner is the natural guardian of minors named above and the interest of petitioner and minors are common and there is no conflict in their interest, therefore, she may be appointed as guardian of minors named above.

Respondents /public at large were summoned through publication in daily "AWSAF" but no one appeared before the court to contest the instant application, hence, they were placed and proceeded ex-parte.

Thereafter, petitioner produced three witnesses.

Attorney for petitioner appeared and deposed as PW-01. He stated that son of petitioner namely Shabbir Ali has been died at Iraq due his duty. Death certificate of Shabbir Ali is Ex.PW-1/1. Copy of his CNIC is Ex.PW-1/2.. Copy of CNIC of petitioner is Ex.PW-1/3 and FRC is Ex.PW-1/4. He

lastly requested for issuance of guardianship certificate in favour of petitioner.


Ibad Ali relative of petitioner appeared and deposed himself as PW-02. He stated that son of petitioner namely Shabbir Ali has been in Iraq during his duty. Husband of petitioner has been died on 19.03.2015. Petitioner is the real mother of Shabbir Ali (late). Copy of his CNIC is Ex.PW-2/1.

Asif Ali nephew of petitioner appeared and deposed as PW-03. Copy of his CNIC is Ex. PW-3/1. He stated that son of petitioner namely Shabbir Ali has been in Iraq during his duty. Husband of petitioner has been died on 19.03.2015. Petitioner is the real mother of Shabbir Ali (late). Copy of his CNIC is Ex.PW-3/1.

There is nothing on the case file to suggest that there is conflict of interest between petitioner and her minor children, hence, the Guardianship Certificate, as prayed for, is granted in favour of petitioner subject to furnishing surety bond in the sum of Rs: 100,000/- (One Lac Rupees) with two local and reliable sureties each in the like amount to the satisfaction of this court with a blank stamp paper. The sureties must be men of means.
