Relative of petitioner alongwith counsel present. He filed special power of attorney on behalf of petitioners, which is placed on file. Inquiry report received. Publication received but no one present on behalf of public at large, hence, placed and proceeded ex-parte. Ex-parte evidence of petitioners recorded as PW-01 to PW-03 and closed. Ex-parte arguments also heard and record perused.

Through this order, this Court is going to dispose of an application submitted by the petitioners for provision of Succession Certificate.

Brief facts of the instant petition are that petitioners seek issuance of a Succession Certificate in their favour on the ground that they are the only legal heirs/successors of deceased Sher Baz Ali S/O Muhammad Baz, R/O Qaum Bar Muhammad Khel, Tappa Khwaidad Khel Trangi, Tehsil Lower, District Orakzai who died on 19.03.2015, copy of death certificate is placed on file. That the deceased has left no other legal heirs except the petitioners. That petitioners Mst: Noor Khela Jan (Widow), Kasrat Begum (daughter), Eshan Haider (son) and Roma Batool (daughter). That petitioners are entitled to receive the Succession Certificate accordingly.

Notice was issued in the name of General Public in News Paper Daily "AWSAF", however, no one attended the Court from the general public, hence, placed and proceeded ex-parte. Accordingly, petitioners were given opportunity to produce ex-parte evidence.

MUHAMMAD JUNATO ALA Civil Judge I JM-II Orakzai at Kalaya Attorney for petitioner appeared and recorded his statement as PW-01. Copy of his CNIC is Ex.PW-1/1. Son of petitioner namely Shabbir Ali has been died in Iraq during his duty. Copy of death certificate of deceased Shabbir Ali is Ex.PW-1/2. Shabbir Ali is unmarried. Husband of petitioner also died. Copy of CNIC of petitioner is Ex.PW-1/3. FRC is Ex.PW-1/4. He lastly requested for issuance of Succession Certificate in favour of petitioners.

Ibad Ali, relative of petitioner appeared and deposed as PW-02. He stated that husband of petitioner has been died on 19.03.2015. Son of petitioner namely Shabbir Ali also died in Iraq during duty. Shabbir Ali is the real son of petitioner. Shabbir Ali is unmarried. Photocopy of his CNIC is Ex-PW-2/1.

Asif Ali, nephew of petitioner appeared and deposed as PW-03. He stated that husband of petitioner has been died on 19.03.2015. Son of petitioner namely Shabbir Ali also died in Iraq during duty. Shabbir Ali is the real son of petitioner. Shabbir Ali is unmarried. Photocopy of his CNIC is Ex-PW-2/1. Photocopy of his CNIC is Ex-PW-3/1.

Likewise, court bailiff was directed to verify the list of legal heirs of deceased Sher Baz Ali, who submitted his report wherein it was verified that the petitioners are the legal heirs of deceased named above.

In the absence of any rebutting evidence, petitioners are hereby declared as the legal heirs of the deceased named above. Succession Certificate be issued in favour of the petitioners on furnishing surety bonds/undertaking in the sum of Rs: 100,000/- (One lac) with two local &

reliable sureties each in the like amount to the satisfaction of this Court to the effect that if there appears any other legal heir of the deceased except above named legal heirs, they would be responsible to the court, along with a blank stamp paper.
