

Plaintiff absent. Defendants have already proceeded ex-parte. Ex-parte arguments heard and record perused.



Brief facts in the backdrop are that plaintiff has filed the instant suit against the defendants for declaration and permanent injunction to the effect that as per CNIC issued by NADRA, correct date of birth of plaintiff is **01.01.1991** and correct name of plaintiff is **Jihad Gul**, however, defendant No.1 has incorrectly entered date of birth of plaintiff as **12.03.1993** and name of plaintiff as Jihad Ali which

is wrong, illegal and liable to be rectified. That defendant No.1 was asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned. Defendant NO.2 to 04 through representative appeared before the court and filed authority letter and was absent on 10.09.2025, hence placed and proceeded ex-parte, while defendant No.1 has already proceeded ex-parte vide order date: 26.08.2025.

After submission of list of witnesses, plaintiff was allowed to produce his ex-parte evidence. Plaintiff produced three witness.

Attorney for plaintiff appeared and deposed as PW-01. He reiterated the averments of plaint. Copy of his CNIC is Ex.PW-1/1. Correct date of birth of plaintiff is 01.01.1991 which is correctly recorded in his CNIC issued by NADRA however, defendant No.1 (Kohat Board) has incorrectly entered the same as 12.03.1993. Copy of CNIC is Ex.PW-1/2 and DMC is Ex.PW-1/3. Furthermore, correct name of plaintiff is Jihad Gul which is also correctly recorded in NADRA record however, defendant No.1 (Kohat Board) record as Jihad Ali. He lastly requested for decree of suit in favor of plaintiff.

Hikmat Khan and Khalil Khan relatives of plaintiff appeared and deposed as PW-02 & PW-03 respectively. They stated that correct date of birth of plaintiff is 01.01.1991 and correct name is Jihad Gul which

correctly mentioned in the record of NADRA, however, defendant NO.1 have incorrectly entered the same as 12.03.1993 and Jihad Ali and lastly requested for decree of the suit in favor plaintiff.

Thereafter, ex-parte evidence of plaintiff were closed.

Claim and contention of plaintiff is that his true and correct date of birth is **01.01.1991** and correct name is Jihad Gul, however, defendant No.1 has incorrectly entered date of birth of plaintiff as **12.03.1993** and Jihad Ali which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. Plaintiff has placed reliance on CNIC issued by NADRA.


There is nothing in rebuttal due to ex-parte while plaintiff produced cogent, convincing and reliable documentary evidence in support of his claim. CNIC issued by NADRA to plaintiff carries weight as presumption of correctness is attached to it. Plaintiff is a young person, therefore, could not be presumed to have instituted the instant suit for any ulterior motive.

As there is nothing in rebuttal due to ex-parte while plaintiff produced reliable evidence, therefore, suit of plaintiff is hereby ex-parte decreed as prayed for. No order as to cost. This decree shall not affect the rights of others, interested if any. This decree shall not affect service record of plaintiff, if any. Defendant No.1 is directed to rectify date of birth of plaintiff as 01.01.1991 and his name as Jihad Gul.

Furthermore, defendant No.1 may verify CNIC from authorities concerned, if deemed necessary.
