**ORDER/JUDGMENT**

Both the parties through attorneys alongwith counsels present.

Parties apprised the court that matter has been patched up between the  
parties through a jirga outside the court and requested for disposal of  
the suit on the basis of compromise accordingly.

Statements of attorneys for parties are separately recorded  
which is duly thumb impressed by them. Copies of CNICs of  
attorneys are Ex. PA while special power of attorney are exhibited as  
Ex. Ex. PB.

Brief facts of the case in hand are that plaintiff had filed the  
instant suit against the defendants for recovery of dower, monthly  
maintenance allowance & dowry articles, fully detailed in the head

note of the plaint. That, the plaintiff is the legal wife of the defendant no. 01 Zakir Ali. That, marriage of the plaintiff was solemnized with defendant no. 01 in accordance with Islamic Law on 21.08.2019 in presence of witnesses. That, from very start of the wed life, behavior of the defendants was harsh and brutal. That, after *Rukhsati*, the plaintiff lived in the house of defendant no. 01 and was fulfilling all her matrimonial obligations. When the dispute arose between parties to the suit, the defendant took out the plaintiff from the home. That a jirga was convened between parties to the suit and plaintiff again returned to her home vide agreement deed annexed to the plaint. After sometime, again the behavior of defendant no. 01, 02 & 03 was harsh with plaintiff. Plaintiff reported the matter to the local police. Plaintiff has left the home and resides in her parent's house. Parents of plaintiff incurred expenses i.e. food, clothes, medical treatment and other necessities of life for the plaintiff. During this period, the defendants neither enquired about plaintiff nor provided any maintenance and even not fulfilled her any other rights. The plaintiff spent the life of a helplessness person. That, the defendants were asked time and again and fulfill the aforementioned rights of the plaintiff, but in vain, hence, the present suit.

Under the due process of law and procedure defendants were summoned. Defendants no. 06 in person while defendant no. 03 in person and as attorney for defendants no. 01, 02 & 04 appeared before the court, however, defendants No. 05 remained absent, therefore, placed and was proceeded ex-parte.

Today, attorney for parties stated at the bar that the matter has been patched up between them outside the court through a compromise deed. Statement of attorneys are recorded separately wherein they reiterated that they have affected compromise and the instant case may be decreed in favor of plaintiff against defendant. Copies of CNICs of attorneys are Ex. PA and special power of attorneys are Ex. PB.

As the matter has been patched up between plaintiff and defendants through compromise as per terms and condition i.e. defendant will pay a lump sum amount of Rs. 3,00,000 (three lacs) in three equal installments to the plaintiff Mst. Saida Noreen and will also pay Rs. 7000/- per month for the child namely Saeed Anwar son of Zakir Ali. Therefore, suit in hand is hereby decreed on the basis of compromise between the parties accordingly. Contesting defendants are permitted to visit the minor once in every month for 03 hours, subject to facility and comfort zone of minor, which includes home, school and court etc. No order as to cost.
