Attorney for petitioner alongwith counsel present. Ex-parte evidence recorded. Ex-parte arguments also heard and record perused.

Petitioner namely Mst: Shazia Bibi widow Mansor Khan, R/O Qaum Feroz Khel, Tappa Qasim Khel, Goeen Tehsil Lower, District Orakzai has filed the instant petition for grant of Guardianship Certificate regarding her minor children namely Hudibia Bibi, Shomaisa Bibi, Warisha Bibi and Musawir Khan. It has been alleged that petitioner is the widow of deceased Mansor Khan who died on 12.08.2025. It is further alleged that petitioner is the natural guardian of minors named above and the interest of petitioner and minors are common and there is no conflict in their interest, therefore, she may be appointed as guardian of minors named above.

Respondents /public at large were summoned through publication in daily "AWSAF" but no one appeared before the court to contest the instant application, hence, they were placed and proceeded ex-parte.

Thereafter, petitioner produced three witnesses.

Attorney for petitioner appeared and deposed as PW-01. He stated that petitioner is his aunt and petitioner is the widow of deceased Mansor Khan, who died on 12.08.2025. Special attorney is Ex.PW-1/1. Copy of CNIC of petitioner is Ex.PW-1/2. Copy of CNIC of deceased is Ex.PW-1/3. Deceased have three daughters and one son, which are minors. FRC consist of 02 pages is Ex.PW-1/4. Copy of his CNIC is Ex.PW-1/5. He lastly requested for issuance of guardianship certificate in favour of petitioner.

Habib Khan cousin of petitioner appeared and deposed himself as PW-02. He stated that husband of petitioner died on 12.08.2025. Deceased Mansor Khan have three daughters and one son. Copy of his CNIC is Ex.PW-2/1.

Abdul Munaf brother in law of petitioner appeared and deposed as PW-03. He stated that husband of petitioner died on 12.08.2025. Deceased Mansor Khan have three daughters and one son. Copy of his CNIC is Ex.PW-3/1.

There is nothing on the case file to suggest that there is conflict of interest between petitioner and her minor children, hence, the Guardianship Certificate, as prayed for, is granted in favour of petitioner subject to furnishing surety bond in the sum of Rs: 100,000/- (One Lac Rupees) with two local and reliable sureties each in the like amount to the satisfaction of this court with a blank stamp paper. The sureties must be men of means.
