

That grandfather of the parties to the suit namely Juma Khan was the owner in possession of the suit property and after his demise, the property was devolved upon the fathers of parties to the suit and they are Aqal Noor, father of petitioners/plaintiffs and Hewa Noor, father of respondents/defendants. Furthermore, stated that the suit property was joint in possession of the fathers of parties and after their demise, it has been devolved upon the parties being their legal heirs. 

That previously dispute was raised between parties to the suit and one Arman Khel regarding exchanged of property (detailed in para no. VI). Upon a jirga was convened on 01.12.2024 in the favor of respondents. Lastly, requested for dismissal of the application.

In light of above discussion, to preserve the suit property, the instant application for grant of temporary injunction filed by plaintiffs is hereby **allowed** and temporary injunction for the statutory period of six months or till disposal of instant suit, whichever comes earlier, is hereby granted in favor of plaintiffs to the extent of further alienation. Furthermore, parties are refrain from interfering with the existing possession of each other in the suit property. No order as to costs. Copy of this order be placed on main suit file while file in hand be consigned to the record room after its necessary completion and compilation.
