




Record received. Injured Bismillah Jan on behalf of complainant present. Counsel for the petitioner submitted application for correction of the FIR number in the petition. Allowed. Moharrir is directed to do the needful.</p> <p>The accused/petitioner seeks confirmation of his pre-arrest bail in Case FIR No. 26, Dated 29.12.2023, u/s 324 PPC registered at Police Station Ghiljo. As per contents of FIR, the local police, while responding to the information regarding the occurrence, rushed to THQ Hospital Ghiljo and found the injured Bismillah Jan in unconscious condition in the emergency room. The brother of injured namely Muhammad Faisal reported the matter on 29.12.2023 at 1950 hours that they were returning to their home after Isha prayer when the accused/petitioner Niaz Meen, who was already armed, was standing on the way and started abusing his brother. The complainant responded by saying that why he was using abusive language; at which, the accused/petitioner fired upon the complainant and his brother; as a result, his brother sustained injuries while he luckily escaped unharmed.
