Upon his body search the local police recovered and took into possession one plastic envelope in white color containing 73-grams ice from the right side pocket. Accused was arrested and issued his card of arrest. Accused disclosed his name as Muhammad Ali.</p> <p>Complete challan against the accused was put in court and after 241-A Cr.P.C proceedings, the accused facing trail was formally charge sheeted. 		<p>pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court. It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused was previously involved in such like cases. There is also no criminal history of the accused available on the file. Keeping in mind the wholehearted confession of guilt by the accused facing trial and being a first offender, a lenient view is taken and accused is convicted and sentenced for offence under section 11-(i) 3 CNSA with simple imprisonment of 03 months with fine of Rs. 03 lacs. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of one & half month. Benefit of 382-B Cr.P.C. is extended to the accused. Case property be dealt in accordance with law.
