## SUMMARY JUDGEMENT 27.10.2025

MUHAMMAD JUNAID ALAM Civil Judge / JM-II

Plaintiff through counsel present. Representative of defendants present. Written statement submitted. Representative of defendants stated that there is unnatural age gap of 15 years between plaintiff and her son namely Muhammad Idrees. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, her true and correct date of birth of plaintiff is 01.08.1990, however, defendants have incorrectly entered the same as 01.08.1995 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, there is unnatural

age of about 15 years between plaintiff and her son namely Muhammad Idrees whose date of birth is 01.01.2010. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between mother and her son. Per record, date of birth of plaintiff is recorded as 01.08.1995. Date of birth of plaintiff's son namely Muhammad Idrees is recorded as 01.01.2010 resulting into unnatural age gap of about 15 years. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 01.08.1990. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
