**SUIT FOR DECLARATION & PERMANENT INJUNCTION**

**JUDGMENT**

31.10.2025

This judgment decides instant case filed by Mst. Zainab Bibi for correction of her parent's names in her record as maintained by the defendants.

**Pleadings:**

The claim as related in the plaint reads that correct names of the father of the plaintiff is Mr. Guli Badshah and that of her mother is Mst. Khawaga Jana while the defendants have wrongly

recorded their names as Farooq Ur Rehman and Mst. Bibi Amina respectively.

It is alleged that when defendants were requested to rectify the mistake extra-judicially, they declined, hence the suit.

In rebuttal, the defendants have raised the regular objections to the legal validity of the claim, the standing of the plaintiff, and factual version of the matter. He asserts that all the particulars regarding parents' names were supplied by the plaintiff himself and are recorded correctly.

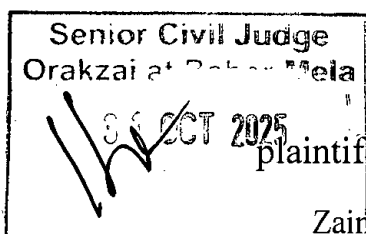
The controversy as related in the pleadings was distilled into the following issues:

**Issues:**

1. Whether suit is valid in its legal frame, and the court is competent to hear it?
2. Whether correct names of the parents of the plaintiff are Mr. Guli Badshah and Mst. Khawaga Jana while the defendants have wrongly entered their names as Mr. Farooq Ur Rehman and Mst. Bibi Amina respectively?
3. Relief.

Thereafter, both sides were invited to produce their evidence to establish the positions they had taken in their pleadings.

Mr. Attique Ur Rehman s/o Guli Badshah, the brother of plaintiff appeared as PW-01, Mst. Khawaga Jana, mother of the

**Reasons/Reasoning:**

Issue wise reasoning of the court following ruling on each issue, and finally on the suit is as follows:

**Issue No 01:**

This issue questions the legal validity of the frame of the suit, and the competence of the forum to hear it. Plaintiff has sought correction of parent's names which clearly is a civil matter, and thus amenable to the jurisdiction of this court under section 09 of the civil procedure code. Other objections such as limitation etc. were not rigorously pressed, and upon examination

of the corpus of the case by the court, were found inapplicable.

Therefore, the issue is decided for the plaintiff.

**Issue No 02:**

This issue houses the heart of the suit: correct parentage of the plaintiff is Mr. Guli Badshah, the father, and Mst. Khawaga Jana, the mother.

Defendants have recorded her father's name as Mr. Farooq Ur Rehman and Mst. Bibi Amina has been written in family tree record of the plaintiff as her mother.

In fact, Mr. Farooq Ur Rahma is the real brother of the plaintiff, and Mst. Amina, her sister in law. It is further recorded that there is an unnatural gap between a child of Mr. Farooq and the plaintiff, which clarifies that her entry into the family of Mr. Farooq is an error.

Further, Mr. Attique Ur Rehman, brother of the plaintiff as PW-1 and testified that the correct father's name of the plaintiff is Guli Badshah and correct mother name is Khawaga Jana while defendants have wrongly incorporated the same as Farooq Ur Rehman and Mst. Bibi Amina.

Mst. Khawaga Jana, mother of the plaintiff as PW-02 and testified that plaintiff is her real daughter and her correct parents name are Guli Badshah and Khawaga Jana, rather than Farooq Ur Rehman and Bibi Amina and requested for decree of the suit.

Another brother of the plaintiff, Mr. Abdul Manan also confirmed the position maintained by plaintiff that he is daughter

of Guli Badshah and Khawaga Jana, rather than Farooq Ur Rehman and Bibi Amina and requested for decree of the suit.

In view of the foregoing, the issue is decided for the plaintiff.


**RELIEF:**
