

Record received.</p> <p>Accused/petitioners namely Abid Khan and Hafiz Khan, both sons of Kamil Badshah, resident of Qom Shiekhan, Tehsil Central District Orakzai, seeks their post arrest bail in case FIR No. 86, dated: 11.10.2025 under sections 379/506/504/34 Pakistan Panel Code, 1860 registered at Police Station Mishti Mela, District Orakzai.</p> <p>Learned counsel for accused/petitioners heard.</p> <p>Perusal of record would reveal that the alleged occurrence took place on 21.08.2025 and it was reported on 21.09.2025 and F.I.R was registered on 11.10.2025. There is un-explained delay of about 22 days in lodging of FIR.</p> <p>There is no eye witness to the occurrence. Source of information regarding involvement of accused/petitioners in the commission of the offence has not been disclosed by the complainant. Nothing incriminating has been recovered from possession of the accused/petitioners or on their pointation. Accused/petitioners have not confessed their guilt before the court. ambit of prohibitory clause of section 497 Cr.P.C and in such like cases grant of bail is a rule and refusal is exception. There is no criminal history of accused/petitioners regarding involvement in such like cases. Moreover, the major role is assigned to the co-accused namely Merab Gul, which is already released on bail by this court, hence, rule of consistency also extended to the present accused/petitioners.

Consequently, application in hand is allowed. Petitioners be released on bail subject to furnishing bail bonds in the sum of Rs. 50,000/- (Fifty thousand) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. Requisitioned record be sent back to the quarter concerned forthwith, while file of this court be consigned to record room after necessary completion and compilation.
