



Order No.02	13.11.2025	<p>Accused/petitioner, Zari Badshah on ad-interim pre-arrest bail with his counsel present. Sr. PP, Abul Qasim for the State present. Complainant present. Mr. Insaf Ali Advocate present and submitted Wakalatnama on behalf of complainant.</p> <p>The accused/petitioner seeks pre-arrest bail in case FIR No. 115, Dated 11.10.2025, u/s 4 Ghag Act of Police Station Kalaya. As per contents of FIR, the complainant, Muhammad Younas, vide Daily Diary No. 04 of 23.09.2025, reported the matter to the local police at 09:00 hours to the effect that the complainant has a civil litigation with the accused/petitioner and his two sons who have raised ghag restraining the sister of complainant from marrying someone else.</p> <p>At the very outset, the present accused/petitioner submitted an affidavit Ex. PA. He also recorded his statement to the effect that; He along with his two sons namely Muhammad Islam and Khwajamin were charged in the instant case FIR No. 115, dated 23.09.2025 at PS Kalaya U/S 4 Ghag Act. Both of his sons are out of the country for earning their livelihood. The sister of the complainant was initially offered</p>

<u>Order No.02</u> 13.11.2025		<p>for engagement with his grandson Shahzim by deceased father of the complainant. He also taken an amount of Rs. 412,000/- against the said engagement. The complainant has also instituted a civil suit against the petitioner for partition of the landed property. He reserved his right to institute a suit for the recovery of Rs. 412,000/- before the civil court against the LR's of Adil Meen (Father of the complainant). However, he has got no objection upon the marriage of sister of the complainant with anyone. If any hurdle was created by him or his sons in this respect in future, the complainant may file an application for reconsideration of my application for BBA. He submits an affidavit in this respect which is Ex. PA.</p> <p>After hearing both the parties and perusal of the record, it was found that though the accused/petitioner is directly charged in the FIR, but keeping in view the affidavit and statement recorded by the accused/petitioner, the BBA petition is accepted and ad-interim pre-arrest bail allowed to the accused/petitioner is confirmed on the strength of existing bail bonds. In case of violation of the affidavit by the petitioner or other accused, the complainant may approach this Court for reconsideration of the application.</p> <p>File of this Court be consigned to record room after its necessary completion and compilation.
