and we performing our duty. Upon the same the accused facing trial started quarrel to us. Accused Hadeed hit the Muhammad Jan and got injured. Complainant charged the accused for the commission of offence. The local police read over the contents of my report which is he signed the same as token of its correctness. The local police prepared the injury sheet of the injured and sent to the hospital through constable Ijaz.

Accused were arrested and later on, released on bail. Complete challan was put in court against the accused facing trial. Accused were summoned. They appeared before the court. Provisions of Section 241-A Cr. PC were complied with. Formal charge was framed. Accused pleaded not guilty and claimed trial. Prosecution was allowed to produce evidence against accused facing trial. Prosecution produced nine witnesses. PW-01, Muhammad Jan/injured stated in his cross examination that it is correct that forest inside Orakzai are not government property. forest. It is further correct that forest act is extended to Orakzai. It is correct that FIR was no lodged under the forest act. It is also correct that it is not available on case file that how many tractors were unloaded by high ups. When IO in the instant case appeared before the court and admitted in his cross examination that there is no previous criminal history of accused facing trial. He further deposed in his cross examination that it is correctly recorded in 161 statement that accused were transferring the woods for personal use inside the Orakzai.

Perusal of the record would transpire that the alleged occurrence took place on 18.03.2024 at 15:30 hours and it was reported on 18.03.2024 at 17:20 hours and FIR was registered on 21.03.2024. Kamal Hussain, Forest Officer, (PW-06), is complainant of the case. He stated in his cross examination that it is correct that the incidents of unloading of woods was not occurrence of 18.03.2024. He further stated in his cross examination that it is not available on case file regarding the prohibition of forest. Furthermore, the complainant not handed over the piece of wood which was used for alleged offence to the police. When PW-07, the IO in the instant case appeared before the court and stated in his cross examination that there is no notification

is available on file regarding the transportation of woods for local purposes. PW-01, Muhammad Jan/injured stated in his cross examination that it is correct that forest inside Orakzai are not government property. It is also noted that he prosecution all the prosecution witnesses produced by prosecution so far have disclosed that all the forest in District Orakzai are not government property rather the people of the areas are owners in possession.

It is also pertinent to mention here that nothing incriminating was recovered from the possession of accused or on their pointation. Source of information regarding involvement of accused in commission of the offence has not been disclosed. Accused have not confessed their guilt before the court. Hence, case of prosecution is full of dents and doubts benefit of which goes to the accused as of right. There is no probability of accused being convicted. Further proceedings would be a futile exercise and wastage of precious time of the court, therefore, application under section 249-A Cr. PC is accepted and accused facing trial are acquitted from the charges leveled against them. They are on bail. Their sureties stand discharged from their liability. Case property, if any, be kept intact till expiry of period of appeal and
