
**SUMMARY JUDGEMENT**

Plaintiff, through counsel present. Representative of defendants

Brief facts in the backdrop are that plaintiff has filed the instant  
suit for declaration cum-permanent injunction to the effect that, as per  
Birth Registration Certificate, true and correct date of birth of plaintiff  
No.1, 02, 03 & 04 are 10.03.2016, 01.01.2010, 01.01.2008 & 01.01.2009  
respectively, however, defendants have incorrectly entered the same as  
are 01.01.2012, 01.01.2008, 01.01.2005 & 01.01.2006 which are wrong,  
illegal and ineffective upon the rights of plaintiff and liable to be  
rectified. That defendants were asked time and again to rectify date of  
birth of plaintiff but in vain hence, the present suit.

Plaintiff has placed reliance on Birth Registration Certificate. Per Birth Registration Certificate, date of birth of plaintiff are recorded as 10.03.2016, 01.01.2010, 01.01.2008 & 01.01.2009. Representative of defendants stated that date of birth of plaintiff may be modified as per Birth Registration Certificate per NADRA SOPs. Copy Birth Registration Certificate of plaintiffs are placed on file. Plaintiffs shall produce Birth Registration Certificates to the office of defendants for the modification in dates of birth as 10.03.2016, 01.01.2010, 01.01.2008 & 01.01.2009. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 10.03.2016, 01.01.2010, 01.01.2008 & 01.01.2009 accordingly. Suit of plaintiffs are decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
