




Order 57	24.11.2025	<p>Parties alongwith their counsels present.</p> <p>Arguments of both parties on the application filed by the plaintiff under Order XXIII Rule 1 CPC have been heard at length.</p> <p>Counsel for the plaintiff submitted that the plaintiff, due to unavoidable circumstances and to avoid further complications in the matter, does not wish to proceed with the instant suit and therefore seeks withdrawal with permission to file afresh of the same by invoking provisions of Order XXIII Rule 1 CPC.</p> <p>On the other hand, counsel for the defendants raised objection on the acceptance of the application and strongly pressed for imposition of appropriate costs. Counsel for plaintiff further stated plaintiff has already amended the plaint, which also contributed to the prolongation of proceedings.</p> <p>The record has been examined. It is an admitted position that the matter has remained pending for a considerable period and a total of 56 hearings have been conducted. Moreover, the plaintiff has twice sought amendment of the plaint during the pendency of the proceedings. Withdrawal of the suit at this belated stage has undoubtedly caused</p>
