


Noor Mir Jan Advocate submitted wakalatnama on behalf of complainant.. Record received.</p> <p>Accused/petitioners, Muhammad Ajmal alias Ajmal Khan S/O Rehmat Khan, Naseeb Ullah S/O Izat Khan and Rehmat Khan S/O Wali Khan seek pre-arrest bail in case FIR No. 26, Dated 15.10.2025, u/s 324/427/148/149 PPC and 5 Explosive Substances Act of Police Station Ghiljo. As per contents of FIR, the local police, while responding to the information regarding the occurrence, rushed to Branch Road Rawinda Peerano Kaley Baland Khel on 15.10.2025. The complainant, Muhammad Adil reported the matter to the local police at 1810 hours to the effect that he along with his son Muhammad Usman and cousin Waleed were on their way to the shops for purchasing household articles and when they reached to the spot of occurrence at 1730 hours, the accused Naseeb Ullah, Ajmal, Khatir, Fawad, Mustafa and Jaido, who were in possession of weapons, appeared from nearby trees and they got furious during the altercation and made firing upon the complainant party; as a result, Muhammad Usman and Waleed sustained injuries while the complainant luckily escaped unharmed.</p>



Order No.02	16.12.2025	<p>The accused Ajmal and Naseeb Ullah also hurled a hand grenade to the shop complainant's cousin namely Said Rehman which caused sufficient damage to the shop.</p> <p>On 22.10.2025, at 0900 hours Muhammad Mustafa (Injured) along with Sabeel Khan and Zeeshan came to the PS where he reported to the police vide DD No. 4 of 22.10.2025, that he along with Sabeel Khan were going to their fields situated at Speen Thall on 15.10.2025 at 1730 hours and upon reaching the place of occurrence, the accused Usman, Adil, Gullu, and Moman armed with sticks and weapons called them to stop and got furious during the altercation and started beating the complainant with sticks, fists and buttstocks of the weapons; resultantly, he sustained injuries on his head and legs. He further reported that Sabeel Khan tried to flee from the spot on which the accused party made firing upon them, but they luckily escaped unhurt. Sabeel Khan got shelter in a nearby house due to fear.</p> <p>At the very outset of the arguments, counsel for the complainant recorded his no objection upon the confirmation of BBA. To this effect, his signature is obtained at the margin of the order sheet.</p> <p>Hence, in view of the above, BBA petition is accepted and ad-interim pre-arrest bail earlier granted to the accused/petitioners is hereby confirmed on the strength of existing bail bonds.</p> <p>Copy of this Order be placed on police/judicial file.
