



Bibi Pali Shah and injured Imdad Hussain also present.</p> <p>The accused/petitioner seeks pre-arrest bail in case FIR No. 131, Dated 15.11.2025, u/s 324/34 PPC of Police Station Kalaya. As per contents of FIR, the local police, while responding to information regarding the incident, rushed to THQ Hospital Kalaya and found the injured Imdad Hussain in unconscious condition and Wajahat Abbas in the emergency room. The complainant, Mst. Bibi Pali Shah reported the matter to the police on 15.11.2025 at 1825 hours that she along with her husband Imdad Hussain, son Wajahat Abbas and mother-in-law Shamail Bibi were on their way from the house of their father to their house and Imdad was ahead of her. When they reached to the spot of occurrence, the accused/petitioner and co-accused duly armed appeared and made firing upon her husband at 1720 hours; as a result, her husband and son sustained injuries. Hence, the present FIR.</p> <p>At the very outset, the complainant and injured Imdad Hussain stated that they have patched up the matter with the accused/petitioner and got no objection upon</p>
