



		<p>During the course of arguments, the learned counsel for the petitioner as well as counsel for the complainant submitted that cross examinations of PW-1 and PW-5 are reserved which are yet to be recorded. Similarly, the statement of injured Rafi Ullah was also not recorded so far. However, the learned trial Court has recorded the closing of prosecution evidence in his order dated 29.11.2025 and statements of the accused were also recorded later on.</p> <p>In view of the above facts, no findings can be given on application u/s 249-A CrPC. However, the learned trial Court is directed to complete the prosecution evidence with the cross examinations of PW-1 and PW-5 with opportunity to injured Rafi Ullah to record his statement and thereafter proceed in the case in accordance with law. The revision petition is, therefore, disposed off accordingly. File of this Court be consigned to record room after its necessary completion and compilation.
