

• **Their appointment to the service shall be subject to the following terms and conditions:**

- I. They will be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, and Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- II. They will be allowed the minimum pay of BPS as mentioned against their names plus other allowances as admissible under the relevant rules. If anyone of the candidates is already in Government Service, he must obtain lien from their department. If their pay is more than the minimum of BPS mentioned against their names, they will be allowed to draw pay which they were drawing before this appointment, subject to permission by the Competent Authority. Their pay shall be fixed at proper stage in BPS mentioned against their names.
- III. They shall be governed by such rules and instructions relating to leave, T.A. and Medical Attendance as may be prescribed from time to time.

- IV. They shall be on probation initially for a period of one year extendable up to two years.
- V. They will be eligible for continuance and eventual confirmation in the post on satisfactory completion of their probationary period, subject to availability of permanent posts and the completion of prescribed training, if any.
- VI. Their service shall be liable to be dispensed with at any time without notice and assigning any reason before the expiry of the period of probation/extended period of probation, if, his work or conduct during this period is not found satisfactory. In the event of termination from service, fourteen (14) days notice or in lieu thereof fourteen (14) days pay will be paid by the Government. In case of resignation, he will give one month notice to the Competent Authority or in lieu thereof one month pay shall be forfeited to the Government. The resignation shall, however, be subject to the acceptance by the Competent Authority.
- VII. They will be governed by the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 and the Khyber Pakhtunkhwa Government Servants Conduct Rules, 1987 and any other instructions the Competent Authority may issue from time to time.
- VIII. If the above terms and conditions of appointment are acceptable to the candidates, they should report for duty to the undersigned immediately at their own expenses. Their offer of appointment shall be deemed to have been cancelled if they fail to report for duty to the undersigned within one month from the date of issuance of this order.
- IX. They shall join duty at their own expenses.




