

**JUDGMENT**

12.12.2025

This judgment decides instant case filed by Hassan

Ahmad for correction of his record as maintained by the defendants.



**Pleadings:**

Facts as recounted in the plaint reads that correct name of the plaintiff is Hassan Ahmad, while the defendants have erroneously recorded the same as Amnal Khan, hence, the suit.

In rebuttal, the defendants have raised the regular objections to the legal validity of the claim, the standing of the plaintiff, and factual version of the matter. He asserts according to family tree, passport and school record, name of the plaintiff has been correctly recorded and requested for dismissal of the suit.

The controversy as related in the pleadings was distilled into the following issues:


**Issues:**

1. *Whether suit is valid in its legal frame, and the court is competent to hear it?*
2. *Whether correct name of the plaintiff is Hassan Ahmad?*
3. *Relief.*

Thereafter, both sides were invited to produce their evidence to establish the positions they had taken in their pleadings.


**Reasons/Reasoning:**

Issue wise reasoning of the court following ruling on each issue, and finally on the suit is as follows:

**Issue No 01:**

This issue questions the legal validity of the frame of the suit, and the competence of the forum to hear it. Plaintiff has sought correction of his name, which clearly is a civil matter, and thus amenable to the jurisdiction of this court under section 09 of the civil procedure code. Other objections such as limitation etc, were not rigorously pressed, and upon examination of the corpus of the case by the court, were found inapplicable. Therefore, the

Issue is decided for the plaintiff.

**Issue No 02:**

This issue houses the heart of the suit: Correct name of the plaintiff.


Mst. Alipa, mother of the plaintiff took the stand as PW-01. She stated that the plaintiff is her real son and the plaintiff's old name was Amnal Khan, but the plaintiff did not like the old name. Now the plaintiff has changed his name from Amnal Khan to Hassan Ahmad. She further stated that the people in the entire area known him with the name of Hassan Ahmad.

Mr. Mansoor Ahmad, cousin of the plaintiff took the stand as PW-02 who supported the stance of the plaintiff. Mr. Hassan Ahmad, took the stand as PW-03 who also supported his stance by repeating the contents of the plaint. He further stated that I have also published a newspaper advertisement regarding my new name.

Defense's witnesses for defendants No. 02, 05 and 06 namely Mr. Iftikhar Ahmad and Shaheen Muhammad took the stand as DW-01 and DW-02 and narrated the same story as in their written statements and refused the stance of the plaintiff.

Plaintiff produced cogent, convincing and reliable as well as oral evidence, in support of his claim and contention. Oral evidence is also supportive of the averments of plaint. Plaintiff is not a government servant; therefore, modification sought by

plaintiff will not affect rights of others.

Keeping in view the above discussion as well as oral evidence available on file, issue No. 2 is decided in favor of plaintiff and against the defendants.

**RELIEF:**

Crux of my issue wise discussion is that suit of the plaintiff is hereby decreed in his favor against the defendants as prayed for. *The correct name of the plaintiff is declared as Hassan Ahmad.* Defendants shall bring their records in line with this judgment and also notify other concerned quarters about the change in name of the plaintiff. Costs shall follow the event.


