


**Order No. 05**

One Wali Jan filed special power of attorney on behalf of petitioners. Publication received but no one appeared on behalf of public at large hence placed and proceeded ex-parte. Ex-parte evidence recorded and closed. Ex-parte arguments heard and record perused.




Petitioner namely Mst: Hashim Naz widow of Tahir Ali, R/O Qaum Mani Khel, Tappa Terai Tehsil Lower, District Orakzai has filed the instant petition for grant of Guardianship Certificate regarding her minor's children namely Asif Ali, Afshan Haider, Mazhar Abbas, Basit Ali and Ismail Hassan. It has been alleged that petitioner is the widow of deceased Tahir Ali who died on 08.07.2024. It is further alleged that petitioner is the natural guardian of minors named above and the interest of petitioner and minors are common and there is no conflict in their interest, therefore, she may be appointed as guardian of minors named above.

Respondents /public at large were summoned through publication in daily "AWSAF" but no one appeared before the court to contest the instant application, hence, they were placed and proceeded ex-parte.

Thereafter, petitioner produced three witnesses.

Special attorney for petitioners appeared and deposed as PW-01. Special power of attorney is Ex.PW-1/1. He stated that deceased Tahir Ali is his son and died on 08.07.2024. Death certificate is Ex.PW-1/2. Petitioner No.1 have five minor's children. FRC is Ex.PW-1/3. Copy of CNIC of petitioner No.1 is Ex.PW-1/4. Copy of his CNIC is Ex.PW-1/5. He lastly requested for issuance of Guardianship Certificate in favour of petitioner.

Muqadam Ali and Farman Ali appeared and deposed as PW-02 & PW-03 respectively. They stated that husband of petitioner on 08.07.2024. Petitioner No.1 have five minor's children. Photocopy of their CNICs are Ex-PW-2/1 & Ex-PW-3/1. They lastly requested for issuance of guardianship certificate in favour of petitioner.

There is nothing on the case file to suggest that there is conflict of interest between petitioner and her minor children, hence, the Guardianship Certificate, as prayed for, is granted in favour of petitioner subject to furnishing surety bond in the sum of Rs: 100,000/- (One Lac Rupees) with two local and reliable sureties each in the like amount to the satisfaction of this court with a blank stamp paper. The sureties must be men of means.
