

Record received.</p> <p>Arguments heard and record perused.</p> <p>Petitioner namely Mujahid Khan son of Sunaf Gul, resident of Qom Mishti, Tappa Mamizai, District Orakzai is seeking return of one motorcycle model no. 2011, bearing registration No. F-1105, engine number 3574934, chassis number U258752 was taken into possession by the local police in case FIR No.97 dated 26.11.2025 under section 11-(i) 5 CNSA Police Station Mishti Mela. Petitioner produced original registration book. Copy of the same is annexed with the petition. Original seen and returned.</p> <p>Record reveals that motorcycle in question was taken into possession by the local police in the above cited case. Per record, there is no rival claimant of the motorcycle in other items. Furthermore, the petitioner was not charged in the instant FIR. Moreover, release of the motorcycle handing over on superdari to the petitioner will not create any vested right in his favor qua the motorcycle as superdari is only a temporary arrangement for the custody of the property during pending inquiry/trial.
