


Syed Muzahir Hussain Advocate present and submitted Wakalatnama on behalf of complainant.</p> <p>The accused/petitioner seeks bail before arrest in case FIR No. 64, Dated 28.07.2024, u/s 302/34 PPC registered at Police Station Kalaya. As per contents of FIR, the local police, while responding to information regarding the incident, reached to THQ Hospital, Kalaya on 28.07.2024 and found the dead body of Syed Abbas s/o Syed Muhammad Sardar in the emergency room. The widow of the deceased namely Mst. Zameen Sahib reported the matter to the local police at 2050 hours that she along with her husband and children were residing in Kachayi Usterzai. She with her husband came to their ancestral house at Behram Zai, Orakzai on the eventful day where her brothers-in-law namely Sajjad Hussain and</p>



Order No.03 07.01.2026		<p>Imdad Hussain (accused/petitioner) and their cousin Nihad Hussain put a noose of rope around the neck of her husband and hanged him from a beam in the veranda at 1800 hours; as a result, her husband died on the spot. Hence, the present FIR.</p> <p>At the very outset, the complainant produced an affidavit and stated that she has charged accused/petitioner Imdad Hussain vide FIR No. 64, Dated 28.07.2024, u/s 302/34 PPC of Police Station Kalaya, for the murder of her husband Syed Abbas. Now, she is satisfied that the accused is innocent and has no concern with the commission of offence. She has no objection upon the confirmation of ad-interim pre-arrest bail in hand in respect of the accused/petitioner as well as his acquittal in the instant case. She does not want to prosecute the case anymore in the court against the accused/petitioner. To this effect, her statement recorded.</p> <p>Hence, in view of the above, the ad-interim pre-arrest bail allowed to the accused/petitioner vide order dated 17.12.2025 is confirmed on the strength of existing bail bonds. File of this Court be consigned to record room after its necessary completion and compilation.
