



LEC-13-7206, chassis no. HA24S618824 and Engine no. K6A4372434 was taken into possession by local police of Police Station Kuraiz Boya, in Case FIR no. 75 dated 27.12.2025 under section 15 of Khyber Pakhtunkhwa Arms Act, 2013 &amp; 34 of Pakistan Panel Code, 1860.</p> <p>Arguments heard and record perused.</p> <p>Brief facts of the case are that case property in shape of motorcar in question was taken into possession by the local police in the above cited case. Per FIR, the local police of police station Mishti Mela were on area patrolling. During patrolling police party were present on barricade. In the meanwhile, one motorcar Alto bearing registration no. LEC-13-7206, chassis no. HA24S618824 and Engine no. K6A4372434 came toward barricade and was stopped for the purpose of checking. Both the persons were deboarded from the motorcar. 
local police recovered and took into possession one pistol 9MM without number alongwith fixed charger containing 05 cartridges of the same bore from the badda shalwar. The body search of the accused seated in front, the local police recovered and took into possession one 30-bore pistol bearing no. 8013 alongwith fixed charger containing 05 cartridges of the same. The driver of the motorcar in question disclosed his name as Sikandar Hayat (petitioner) while the other person disclosed his name as Syed Amil Hussain.

Now the petitioner through instant application alleged that he is the real owner of motorcar in question and seeks return of the same on superdari. In this respect he produced the original document, seen and returned, copy retained on the file.

Perusal of the recovery memo would reveal that motorcar in question was recovered from the possession of present petitioner.

Furthermore, there is no rival claimant present before the court. Furthermore, no such valid reason or sufficient cause has been disclosed by prosecution in order to dismiss instant application.

Hence, keeping in view the aforesaid discussion instant Superdari petition is hereby **allowed** and petitioner
