

		<p>phone was unreachable. The complainant came to know that the dead body of his brother was lying in the mountain; upon which they reached there and found his corpse smeared with blood. The complainant further reported that he is completely certain that the deceased has been done to death by the accused/petitioner and co-accused Shahzad Khan with firearm due to blood-feud enmity. Hence, the present FIR.</p> <p>At the very outset, the complainant and the son of deceased appeared before the Court and stated that they have got no objection upon confirmation of pre-arrest bail of the accused/petitioner. To this effect, their joint statement recorded.</p> <p>In view of the above, the ad-interim pre-arrest bail earlier granted to the accused/petitioner vide order dated 08.12.2025 is confirmed on the strength of existing bail bonds. File of this Court be consigned to record room after its necessary completion and compilation.
