



No FSL report is available on file that whether the recovered substance is ICE or not will be determined during trial. Investigation has already been completed and accused/petitioner is no more required to the local police for investigation. Resultantly, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 70,000/- (Seventy thousand) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record.
