




Sr. PP, Abul Qasim for the State present. Complainant Muhammad Ismail present.</p> <p>The accused/petitioners seek bail before arrest in case FIR No. 04, Dated 17.03.2025, u/s 302/34 PPC registered at Police Station Ghiljo. As per contents of FIR, the brother of the deceased namely Muhammad Ismail made a report to the local police in the police station on 17.03.2025 at 1200 hours that his brother told him that he was present outside his house when the accused/petitioners arrived there at 1230 hours and asked him that why he has obtained the lease of a land from Fazal Deen which is in their possession. He further reported that the accused/petitioner got furious during conversation and the accused/petitioner Akram Khan caught hold of him whereas the petitioners Zakriya and Hakeem Ullah assaulted him with sticks and stones; as a result, the deceased sustained injuries. He was taken to KDA Hospital for treatment wherefrom he was referred to Peshawar where he succumbed to his injuries. Hence, the present FIR.</p>

He stated that he is brother of the deceased and he has charged accused/petitioners namely Muhammad Akram, Muhammad Zakriya and Hakeem Ullah sons of Muhammad Ilyas, R/O Qaum Mamozai, Ghiljo, vide case FIR No. 04, dated 17.03.2025, u/s 302-34 PPC of Police Station Ghiljo, for the murder of his brother Atta Ur Rehman. He has got no objection upon the confirmation of his ad-interim pre-arrest bail petition in hand in respect of the above-named accused/petitioners. To this effect, his statement recorded.</p> <p>In view of the above, the ad-interim pre-arrest bail earlier granted to the accused/petitioners vide order dated 24.11.2025 is confirmed on the strength of existing bail bonds.
